## **Associate Membership** may be granted to:

- (1) Any person who has been licensed to practice law in this state for less than one year, or any person who has actively engaged in any one or a combination of, the following-named occupations for less than one year: secretary, legal assistant, office administrator, stenographer, typist, clerk or reporter in any law office or court, or in work of a legal nature in a trust department of a bank or trust company, any business which provides legal support services, including legal placement, copying or document processing, process serving, or the legal department of any public or private institution, including governmental offices or,
- (2) Any person formerly employed in any of the occupations described above, but who has had such employment interrupted.

## **Student Membership** may be granted to:

- (1) Any person who is enrolled in a training course designed to lead to employment in the occupations described above. A student member shall be allowed to retain such status for no more than one (1) year after completing the training course in which said member is enrolled.
- (2) An associate member or student member shall have the right to vote on matters pertaining to this association but not to matters pertaining to LPI. An associate member or student member shall have the right to serve as a committee chair, but shall not be eligible to hold office.

An associate member or student member shall be allowed to retain such status until they have been engaged in work of a legal nature as defined above for one year. After having been employed in legal work for one year, an associate or student member may become an active member by submitting an application for active membership, making payment of the annual dues (in addition to the initiation fee of LPI, if any), and being approved by a majority vote of the members of the Board of Directors.

**Application for Membership.** An application shall be accompanied by the first year's dues and initiation fee, the current initiation fee of LPI, if any, one-half the current per capita tax of LPI along with satisfactory proof that the applicant is eligible for membership. Membership is contingent upon approval by a majority vote of the members of the Board of Directors. If the applicant has applied prior to attending a qualifying function, the application may be approved conditionally by a majority of the Board of Directors.
