

### PRESIDENT'S MESSAGE FRANCIE SKAGGS

#### How Our Heroes Teach Us That We Can Soar, Even When There Are Obstacles

#### Dear Members:

For the past few weeks, the world united for poignant and unprecedented moments during the 2020 Tokyo Olympics (which were finally held this year). For 16 days, we took a break from the news of the ubiquitous pandemic and lived through the joy and heart-felt emotions of our American athletes who won an overall 113 medals, including 39 gold medals.







#### LPI: Returning to Work & Personalities

Presented by Diane Camacho, CLM, Founder & CEO of DLC Consulting Services, LLC

On August 5, 2021, Diane L. Camacho, CLM, presented the webinar Returning to Work Means Returning to Different Personalities for the LPI Continuing Educational Council. Diane Camacho, who is the Founder and CEO of DLC Consulting Services, LLC, has over 25 years of experience in managing law firms and therefore is quite experienced with the dynamics of a law firm and its culture.

Diane stated that in the last year-and-a-half, we had to adapt to a more solitary environment allowing more freedom and control over our work and schedule. We have not had others looking over our computer screen to see what we are working on and have easily avoided difficult personalities by simply not having to engage with them. We will once again need to learn how to work with others and again face some of the challenges that come along with coworkers.

Diane recognized that some legal professionals have found working remotely easier while others found to be more difficult. We will now need to prepare for the big return, and that office environment will be different from the one we left in March, 2020. No longer will there be shared community space, free food, social events or greeting others with a handshake.

Diane explained how working remotely can also present many setbacks. Human beings are social creatures and isolation affects parts of our brain that control cognitive ability. A reduction in social interaction affects other regions in our brain that can lead to forgetfulness, dementia and depression. She shared some articles written by several professors at UC Riverside that explained the long-term consequences of social isolation in more detail and why returning to our social environment is important.



#### Returning to Work & Personalities Cont'd.


In her PowerPoint, Diane had an excellent list of bullet points to help prepare and soften the shock of returning to the office:

- · Go to the office early
- Get a new plant and fix up your desk
- · Buy a new outfit for your first day of work

These suggestions are a prudent way to make the acclimatization a little more comfortable. Diane presented the attendees with six important questions that received some interesting responses:

- Has your firm talked to you about Post-Pandemic remote work?
- Will your firm be allowing Post-Pandemic remote work?
- Are you working at the Office Full-Time now?
- Are you working at the Office Only Part-Time?
- Has your firm told you a requirement for coming back to work is vaccination?
- What would you like to do?

For the first of these questions, 41 percent of the responders said that "yes," their firm had talked about Post-Pandemic remote work, "but very vaguely"; 34 percent said "no"; and only 25 percent said that they have been given "very clear guidelines." For those who, like 75 percent of these responders, are unclear about the guidelines of post-pandemic work, it might be helpful to reach out to your Human Resources Department for more clarity to help your planned return.





#### Returning to Work & Personalities Cont'd.

We will be returning to an office where others have also been isolated for a long time. Many may have experienced much loss and stress from the tumultuous events of the past year. There will be anxiety and we need to remember to give each other a little slack, just like we do if someone's parent passes away.

Diane listed bullet points to remember when we return such as: be sincere, be honest, be open and listen. Remember to have a positive attitude and create a mantra. Amanda Smith, director of Medical Student Support & Wellness at UC Riverside said, "Remember that a sense of adjustment will take time just as it did with the initial experience of quarantine."

This webinar was free for everyone in the legal profession. I now feel like I have some new lessons to help me cope with the return and will be definitely buying a new outfit and plant for my desk. I highly encourage everyone to visit the SFLPA and LPI websites and look at the upcoming educational events like this one on the events pages. If your office has not yet made the shift to eFiling, it may be time to start! Although different courts will adapt to eFiling at different speeds, some offices may have trouble keeping up with more rapid implementation timetables if they haven't laid the groundwork beforehand.

When you fully shift to eFiling, it will require some changes in technology, training, and organizational flow. To help your office adapt, we've put together a few tips:

#### Attend all training opportunities


Oftentimes, individual courts will offer some training opportunities. It's best to be on the lookout for these and participate in training from your eFiling service provider. For example, many eFiling service providers offer their own training and webinars!

#### Keep in contact with the court

Although this is a simple step, it can be invaluable! Ensure you're on your local court's mailing list. When you work with a California eFiling service provider, they can help keep you informed about changes statewide!

#### Upgrade to the right technology

If you've been avoiding a technology upgrade, it could be time to make the change! When it

comes to eFiling, the most important tool in your arsenal is a good scanner! You'll be required to scan documents at a certain DPI minimum. You'll also need professional PDF software that will allow you to comply with court requirements. You may be asked to apply optical character recognition or add bookmarks throughout your exhibit, for which you'll need full-service software.

#### Learn more about fees and accounting

As your law firm makes the transition from paper to electronic filing, more of the court filing fees will be paid through the eFiling portal. Most eFiling service providers (EFSP) require a credit card or direct access to your checking account. This can cause issues with cash flow, credit card limits and overdrafts. At some eFiling service providers, you don't have to worry about limits or errors in staff reporting because they advance the fees. Make sure to research and choose an eFiling service provider with a flexible accounting system, so you get to choose the options that best fit your business needs.



## SFLPA's Scholarship Program

by Felicia Masters

Hi!

My name is Felicia Masters and I am the Scholarship Chair for SFLPA. As a single mother with a daughter in law school, I am very aware of the costs associated with higher education in California. Through this experience, I have become passionate about our scholarship awards as I recognized that there is a growing need for more financial support and assistance for those interested in pursuing careers in the legal industry.

LPI budgets for two scholarships a year for a total of \$3,000 and anyone in the legal field excluding law students is eligible. The funds that are awarded do not have to be used for just tuition or books, as we do not specify how your funds will be used. In addition, SFLPA awards a separate scholarship in addition to LPI's scholarships. Application deadlines are April 1, 2022. Below are the following scholarship categories:

- (A) High School Student: Applicants shall be restricted to seniors who will have successfully completed high school by the end of June 2022 and will be enrolled in the fall semester, immediately following the school year, in college or business school, which offers a course of study in the legal field. All applicants must be living in California, considered legal residents of the State of California, and must attend an approved program or course of study of a legal nature during the scholarship year.
- (B) College Student: Applicants shall be restricted to students who will have completed at least one year of college by June of the school year and will be enrolled in the fall semester, immediately following the school year, at a college or business school in a course of study in the legal field until all such courses have been taken to satisfy the requirements for a degree or certificate in said legal-related program. All applicants must be living in California, considered legal residents of the State of California, and must attend an approved program or course of study of a legal nature during the scholarship year.



## SFLPA's Scholarship Program Cont'd.



(C) Career Change Student: Applicants shall be restricted to students who will be enrolled in the fall semester in a college or business school in a course of study in the legal field and shall be an individual who either (a) desires to reenter the workforce after a prolonged absence but requires training or specialized education in order to qualify as a candidate for a position in the legal field; or (b) has been in the workforce for a number of years but desires to enter the legal field and wants to receive the training or specialized education needed to do so. All applicants must be living in California, considered legal residents of the State of California, and must attend an approved program or course of study of a legal nature during the scholarship year.

#### Scholarship Checklist:

BIOGRAHICAL LETTER FROM APPLICANT: Letter should state the reasons why applicant should receive a scholarship, academic achievement of the applicant, applicant's motivation to pursue a career in the legal field, applicant's future goals, and applicant's financial need. The letter should be typewritten on 8.5" x 11" paper and addressed "To Whom It May Concern."

THREE LETTERS OF RECOMMENDATION: Letters of recommendation should be from someone other than a family member or a member of LPI (e.g., long-term family friend, teacher, school counselor, employer, or coworker) and should contain the author's relationship to the applicant. Additional items to include in the letter are a description of the applicant's personal traits (character, personality, and goals) and the applicant's school or work experience and ethic. Letters should be typewritten on 8.5" X 11" paper and addressed "To Whom It May Concern."

UNOFFICAL SCHOOL TRANSCRIPT: LPI reserves the right at any time to request an official transcript from the applicant. "Official transcript" shall be defined as transcripts printed on original school letterhead. A copy of the

transcript may be accepted if it contains either an embossed school seal or certification identifying the copy as a true copy of the original transcript.

RESUME (Category C only): The resume should list applicant's legal and/or secretarial experience, if any. Resume must include dates of employment, employer name and address, position, and reason for leaving.


