#### FIRST QUARTERLY CONFERENCE BOARD OF GOVERNORS MEETING

The First Quarterly Conference of Legal Professionals Incorporated was held August 12 – 14, 2022 at the DoubleTree by Hilton in Orange, California. Orange County LPA and LPI co-hosted the conference.

Most attendees arrived on Friday, August 12, and the weekend began with the Welcome Reception, followed immediately by a Pizza and Bingo Party! Many of us took the opportunity to try our luck at Bingo and fabulous prizes were won by several.

Saturday morning began with a Continental Breakfast before the Board of Governors meeting. The Board of Governors Meeting was called to order at 9:00 a.m. by President Rod Cardinale, Jr. The Pledge of Allegiance was led by Ron Ackland. The Code of Ethics was read by Heather Nowak. The President then introduced the Past Presidents who were in attendance or participating via Zoom.

Executive Secretary Bettina Jacobsen called the roll. There were 20 Governors present, constituting a quorum. The Executive Secretary reported that no correspondence was received in the prior quarter.

The Minutes of the May 2022 Pre-Board of Governors Conference Meeting were approved as distributed. The Minutes of the May 2022 Post-Board of Governors Conference Meeting were approved as distributed. On motion made and seconded, the actions of the LPI Treasurer in paying the routine bills of LPI were ratified.

The elected officers then gave their reports. Copies of their written reports are available on LPI's website. I am happy to email a copy of the reports to anyone who requests it.

Editor-in-Chief Linda Lane, CCLS reminded the membership that the forms included in the Law Office Procedures Manual are samples only, and should not be used other than as an example of how to complete the form.

Renee Evans, CCLS, Educational Program Coordinator reminded everyone to send MCLE records regarding any educational programs presented to her. Historian Shannon Quigley reported that she is establishing a Dropbox link so that local associations can share pictures with her, and have access to the pictures that she takes. No other chairman gave a report at this conference. There was no unfinished business to come before the meeting.

President Rod announced under new business that LPI's contract with CAMS has been renewed on the same terms as the previous contract, except for an additional \$1,750 annual amount to be paid. He also announced that the 2023 Annual Conference will be held May 11 – 14 in Downtown Las Vegas. A special committee has been appointed for the planning of this conference. There being no other business to come before the corporation, the meeting was recessed until the second session to be held on Sunday, August 14, 2022.

A Roundtable Lunch which was open to all members attending the conference followed the morning meeting. This gave everyone a chance to discuss items of interest together. This is part of the new conference format. The afternoon continued with opportunities for networking and continuing education. We then enjoyed a banquet dinner, and time of socializing and networking for the evening. The music was great and many of us got on the dance floor for some fun.

Sunday morning began with a Continental Breakfast in lieu of a plated brunch. The inspirational speaker for the morning was Sylvia Marsh of Orange County LPA.

# GOVERNOR'S REPORT

The Board of Governors meeting was called to order at 9:01 a.m. by President Rod Cardinale. Roll was taken. Brenda Johnson, CCLS was seated as Governor *Pro Tem* for Sacramento County LSA. There were 19 Governors present which constituted a quorum.

The Governors were then asked to vote on the proposed Bylaw Amendments. The Governors voted to increase the LPI per capita tax from \$30 to \$40 effective May 1, 2023. Student and associate members pay one-half the annual per capita tax. This increase was made to allow LPI to provide certain continuing education opportunities at no cost to the members.

The Governors then approved the amendment to delete the appointed officer position of Legal Specialization Sections Coordinator, as well as the positions of Legal Specialization Sections. This change was made as part of the restructuring of the presentation of educational opportunities.

As SFLPA Governor, I sponsored the amendment proposed by Frances Skaggs, CCLS, to change the terms "Chairman" and "Chairmen" in the Bylaws to "Chair" and "Chairs". This change is effective immediately and the LPI Parliamentarian has been authorized to make this change to the Bylaws wherever they appear. The Governors approved this change to the Bylaws.

The Governors also approved the amendment of the Bylaws to reflect the change in the term "LPI Past President" to "LSI/LPI Past President, and the LPI Parliamentarian has been authorized to make this change in the Bylaws.

# CONT'D.



The Governors were also asked to vote on proposed changes to the LPI Standing Rules. Effective immediately, the monetary awards for the bulletin contest have been increased by \$25 as follows: First Place:\$100; Second Place: \$75 and Third Place: \$50. As SFLPA Governor I also sponsored the change suggested by Frances Skaggs, CCLS to change the terms "Chairman" and "Chairmen" to "Chair" and "Chairs". The LPI Parliamentarian will be making these corrections to the Standing Rules.

The Governors approved an amendment to Standing Rule 11 which outlines the process for Legal Specialization Sections Membership. In lieu of Specialization Sections, the educational courses will be provided under the Education Council. There will be three tiers of education: LPI University, LPI Technology Training and LPI Continuing Education. Courses under the LPI Continuing Education category will be free for all LPI members. It is hoped that members will avail themselves of the courses offered at this level. President Rod is continuing with the tradition of awarding four scrip tickets to local associations. While SFLPA was not a winner in this contest, we can look forward to possibly receiving one for a future conference. The meeting was then adjourned by President Rod Cardinale, Jr.

It was my pleasure and privilege to represent SFLPA as Governor at this conference. If you ever have questions regarding matters concerning LPI, please don't hesitate to let me know. The next Quarterly Conference will be held November 11 – 13, 2022, at the Hilton Arden West in Sacramento. The hosting associates are Sacramento LSA and Placer County LPA. Sacramento is an easy drive from any part of the Bay Area. I hope you will consider attending the November conference. You will get the benefit of networking and educational opportunities as well.





This month, we celebrate Latinx pride by honoring those who speak out and stand up. Their courage, persistence, and existence has changed the world. iSi, se puede!

- X González Parkland shooting survivor, gun control activist, co-founded advocacy group Never Again MSD, famous "We Call B.S." speech and viral speech at Washington DC summit.
- Dolores Huerta Labor leader and civil rights activist, co-founded National Farmworkers Association (now UFW) with Cesar Chavez, created the slogan "iSi, se puede!" i.e. "Yes, we can!"
- Diego Rivera Prominent Mexican painter, best muralist in the world, lived in SF with fellow artist, lover and sometimes-wife Frida Kahlo, controversies over art include Lenin inclusion (Rockefellers destroyed that one), "God does not exist" atheist proclamation; Rivera refused to be censored, and used his commission from the Rockefeller destroyed mural to repaint the same mural in Mexico City.
- Frida Kahlo Mexican artist famous for self-portraits and Surrealist/magical realism style, was a medical student until serious injury; married artist Diego Rivera at 22 in SF, art explored chronic pain experiences from childhood poliorelated disability and bus accident at 18; feminist and Latina icon.
- José Andrés world-famous Spanish chef who helped bring small-plates dining concept to America, owns restaurants in DC, LA, Las Vegas, South Beach,
   Orlando, Chicago, and NYC, founder of World Central Kitchen (WCK), non-profit that provides meals to refugees after natural disasters, awarded 2015
   National Humanities Medal at the White House in 2016.
- Julia Alvarez famous poet, novelist, and essayist on Dominican-American immigrant experience, family forced to leave Dominican Republic due to father's involvement in political rebellion, received National Medal of Arts from President Obama.
- Hon. Sonia Sotomayor First woman of color and first Latina to serve on the Supreme Court; born in the Bronx to Puerto Rican parents; graduated with honors from Princeton and got law degree from Yale; edited Yale Law Journal; nominated to Supreme Court by President Obama in 2009; dissented in Citizens United v. Federal Election Commission and Dobbs v. Jackson Women's Health Organization.

- Cesar Chavez Mexican-American labor leader and civil rights activist, along with Dolores Huerta, co-founded NFWA, and worked with the Community Service Organization (CSO) to help laborers register to vote; we honor his contributions with CA state holiday Cesar Chavez Day.
- Sylvia Rivera New York trans rights activist who marched with the Gay
  Liberation Front and co-founded STAR, an org dedicated to helping homeless
  young drag queens, gay teenagers, and trans women; famously stormed the
  stage in 1973 with fellow drag queen Lee Brewster to interrupt Jean O'Leary's
  speech.
- Lin-Manuel Miranda Puerto Rican and Mexican-American actor, rapper, songwriter, playwright, and filmmaker, known for the Broadway musicals Hamilton and In the Heights, and the soundtrack of Disney's Encanto; received three Tony Awards, three Grammy Awards, two Emmy Awards, and a Pulitzer Prize, and many others.
- Dr. Ellen Ochoa Mexican-American engineer and NASA astronaut who was the 11th director of the Johnson Space Center, and JSC's first Hispanic director; first Hispanic woman to go to space on a 9-day mission aboard the Space Shuttle Discovery.
- Roberto Clemente Puerto Rican professional baseball player, played 18 seasons in Major League Baseball, first Latino player in the Baseball Hall of Fame, 1966 National League MVP, NL Batting Leader for 4 years, Gold Glove Award winner for 12 straight seasons, died in plane crash on a mission to deliver aid to Nicaraguan earthquake victims, MLB named annual Commissioner's Award in his honor.

#### Central District of California - Annual Bar Membership Renewal Fee

On May 28, 2020, the Central District of California issued General Order No. 20-07, which instituted an annual renewal fee of \$25 for all members of this Court's Bar. See General Order No. 20-07, available at <a href="https://www.cacd.uscourts.gov/court-procedures/general-orders">www.cacd.uscourts.gov/court-procedures/general-orders</a>. Beginning in 2020, this annual renewal fee of \$25 is due on September 1 of each year for all attorneys admitted to the Court's Bar before September 1 of the prior year.

# Contra Costa Superior Court: eFiling Service Disruptions

Contra Costa Superior Court, Probate Division, is currently experiencing an eFiling service disruption processing transactions. The Contra Costa Probate team has asked that all new probate filings be submitted over the counter or in person due to their eFiling disruption until further notice.

If anyone has an existing transaction that needs immediate attention, please print the confirmation page, including the Court's transaction number, and submit in paper, over the counter. The Court will file the documents as of the original submission date.

#### Kern Superior Court: Filing Reminder - "Confidential" Documents

The filing party has sole responsibility for maintaining the confidentiality of documents and information transmitted to the Court for filing. Court clerks and staff do not review documents for compliance.

Filing parties may designate documents "confidential" in the Court's electronic filing system, or may exclude or redact personal data identifiers or information from documents, including exhibits, or may obtain a sealing order, if warranted. It is the filing party's responsibility to take the appropriate action. Please see Local Rule 1.10.

It has come to the Court's attention that some attorneys have come across sensitive client and medical information while reviewing files online. Such information may have been included, without redaction or a "confidential" designation, in a petition to approve a minor's compromise or an MSC statement. If you find such information, you may wish to obtain a sealing order, or you may ask the civil unit to assist you in retroactively rendering that information "confidential."

# Trans History Spotlight: Andrea Jenkins




There are so many reasons for our LGBTQ+ community to celebrate in 2022! We have made incredible progress in the past few decades, and in many places in America, we have freedom none of us thought possible in our younger days. Despite recent pushes to walk back the clock and take away hard-won rights, our community is stronger than ever, and we are finding and using our voices in every corner. Our transgender family, colleagues, and friends have been at the forefront of the battle for equality, and as the most visible members of our community, they have fought the good fight to make our voices heard. Today, we honor them and share their stories.

#### **Andrea Jenkins**

Andrea Jenkins, who won the City Council election in Minneapolis' Eighth Ward on November 7, 2017, is the first openly trans Black woman elected to serve in American public office. Andrea is one of the many women who chose to run for public office after the 2016 election caused a reckoning and forced us to face the institutional bigotry and racism that infects not just American politics, but our society at large. She won in a landslide—securing 73% of the vote—due to her name recognition and long experience in local politics, including as an aide for multiple City Council members, and for years before that for the Hennepin County government as a vocational counselor. She was endorsed by the Minneapolis Star Tribune and Rep. Keith Ellison, and her campaign slogan of "Leadership. Access. Equity." and focus on raising the minimum wage, building more affordable housing, and addressing police reform were exactly what Minneapolis, and perhaps America, needs right now. "As an African American trans-identified woman, I know firsthand the feeling of being marginalized, left out, thrown under the bus. Those days are over. We don't just want a seat at the table, we want to set the table."

Andrea's victory speech exudes such power and confidence—but she wasn't always so confident. Born to a single mother in West Chicago in 1961, she grew up in a rough blue-collar, inner-city neighborhood. Young Andrea was in the Cub Scouts and a football player, and seemed to be a typical child. She realized


she was different around six years old, when she observed two drag queens on a city bus, and witnessed others staring and making fun of them. Andrea identified with the queens, and sadly believed that she couldn't let anyone know how she felt or who she really was. She kept her secret close for years, and moved to Minnesota in 1979. As a popular guy in college, her peers chose her to be fraternity president at the University of Minnesota—but when one of them caught her in a relationship with a man, she was ostracized and kicked out of the fraternity house. Over the next ten years, Andrea identified as gay, married, had a beautiful daughter, Nia, and then divorced. She wasn't quite ready to share her trans identity with the rest of the world.

After working for the government for some time and finding support at the University of Minnesota, Andrea was ready to live as herself, despite experiencing bigotry and discrimination from colleagues that refused to use her name and would only refer to her as "Co-Worker." Andrea finally made it official with the State of Minnesota, legally correcting her name and gender with support from many current and former colleagues, including State Senator Jeff Hayden. She came to recognize that the best way to combat bigotry and change hearts and minds was by showing up as her true self. "I can do that through my daily existence," she shared. "Being visible. Being included in conversations that aren't necessarily LGBT-specific, but having a voice and representing a community that has been marginalized for a long time." Andrea was recruited to join Robert Lilligren's team when he ran for City Council in 2001, and when he was elected, he made her his top staffer. Four years later, Andrea was asked to serve as an aide for Councilmember Elizabeth Glidden, and during her eight years on Glidden's staff, built upon her large network and became even more well-known in the community. She was appointed a Bush Fellow in 2011, received several prominent fellowships and grants, and headed the Transgender Oral History Project at UMinn's library, recording hundreds of hours of interviews in the Midwestern U.S. Andrea worked with Hayden Mora to establish the Trans United Fund, a political committee dedicated to helping transgender nonconforming people win elections which provided critical support to the




successful campaigns of Phillipe Cunningham in Minnesota and Danica Roem in Virginia.

Andrea helped create the Trans Equity Summit and a Transgender Issues Work Group, ensuing in a policy for city businesses to create single-stall, gender neutral bathrooms and specialized training for law enforcement officers. Officer training and response came into the spotlight several years later when George Floyd was murdered by a Minneapolis officer on the street in the ward Andrea represents. Along with her community, Andrea first supported eliminating or greatly reducing the Minneapolis police department's emergency call response, but later decided a better approach was to back law enforcement in doing their job to protect and serve the community, while increasing efforts to secure funding and resources to help those most affected by institutional racism. She came head-to-head with activists who surrounded her car for hours until she agreed to sign a list of demands. Recognizing the pain and frustration of her community, Andrea worked even harder to make their voices heard and turn the conversation into real change, writing and passing legislation to address racial profiling and police brutality, and voting for the Minneapolis 2040 Plan to change citywide zoning to allow multi-family housing in areas previously restricted to singlefamily homes, which will make a concrete impact to mitigate the long-term effects of redlining on Black communities.

Andrea won re-election with 85 percent of the vote on November 2, 2021. Now serving as Minneapolis City Council President, she continues her work to amplify the voice of the LGBTQ+ and BIPOC communities and bring lasting change by demanding more than just a seat at the table. Andrea is a trailblazer who is leading the way for other successful transgender lawmakers, and heralds a kinder and more inclusive movement in American politics. She made the cover of Time magazine in January 2018, and someday her brilliant smile will grace our children's history books. Andrea told Time: "I view my role in history really just as a relay runner in the long race towards human progress and racial justice in this country. It's a journey, and we all have a role

to play." In these dark times, remember her call: "We have to remain hopeful. My ancestors were enslaved in this country, and they hoped and prayed that someday, somebody like me would be able to have a role in shaping how we live. Now that dream has come to fruition. And even though we have a long way to go, we have to hope that we'll reach our goals."
